### **Collection**

When you use this website Blu Ginger Indian Restaurant will only collect necessary personal information, which you provide, to us and information about how you use our website, for example by making a purchase or posting original content to our site. This information includes your name, home or work address, phone number, e-mail contact and information about the products and services, which interest you. Blu Ginger Indian Restaurant will only collect personal information by lawful and fair means and will let you know where and how to contact us.

### **Use**

Blu Ginger Indian Restaurant may use your personal information to:

### **Security Policy**

Your credit card details are transmitted through a secure, third party gateway which sends these details to the bank. All credit card details are protected using SSL (Secure Socket Layer) encryption and currency

However, your credit card details are not stored by Blu Ginger Indian Restaurant and will destroy or permanently de-identify personal information if it is no longer needed for any purpose.

We will not use or disclose your e-mail address and mobile phone number to any third party without your explicit consent, nor will you get any unsolicited bulk e-mail (also known as "spam") with any commercial offers or advertisements, as a result of your registration of details with Blu Ginger Indian Restaurant.

When you use this website, our Internet Service Providers record your visit and logs the following data for aggregate statistical purposes - server address, top level domain name (e.g. .com, .gov, .au, .uk etc.), date and time of visit, pages accessed, previous website visited and type of web browser and operating system used. This information together with any other feedback / information you provide us from time to time are used to continuously improve our service.

No attempt will be made to identify users or their browsing activities except, in the unlikely event of an investigation, where a law enforcement agency may exercise a warrant to inspect service provider logs.

Your IP address is logged upon placing an order as part of our commitment to fraud prevention and security. Blu Ginger Indian Restaurant will pass on any information related to suspected fraudulent activity to the appropriate authorities.
